



25<sup>th</sup> Annual CANADA LIFE CN TOWER CLIMB FOR WWF-Canada  
RELEASE AND INDEMNITY

**IMPORTANT!**

Climbers under 18 years of age must have a parent/guardian present to sign this document prior to climbing. Climbers under 12 years of age must be at least 42 inches tall (or 3½ feet) and accompanied by an adult during their climb. **Climber agrees not to carry anything up the stairwell, including but not limited to: water bottles, portable music devices, or an infant or child.**

World Wildlife Fund Canada (“WWF-Canada”) has organized and will run the 2015 Canada Life CN Tower Climb for World Wildlife Fund (the “Event”) on Saturday, April 25<sup>th</sup> and Sunday, April 26<sup>th</sup>, 2015. The Event involves participants climbing the stairs of the CN Tower. **I know that the Event involves physical activity and I voluntarily assume the risks of participating in the Event. I understand that these risks include exertion-related health problems, falls, collisions with other participants and other incidents that could cause loss to property, personal injury or death, and related losses.** In return for my being permitted to participate in the Event, I agree to the terms of this Release and Indemnity. I agree to this Release on behalf of myself, my heirs, executors, administrators, successors and assigns (the “Releasers”).

**By signing this Release and Indemnity,** I unconditionally release, on behalf of the Releasers, the following parties: The Canada Life Assurance Company, WWF-Canada, World Wildlife Fund International, Red Sky Consulting Ltd, Maximum Arrest Force Inc., CN Tower, Canada Lands Company (CLC) Limited, City of Metropolitan Toronto, Rogers Stadium Limited Partnership o/a Rogers Centre, Metro Toronto Convention Centre, 4033795 Canada Inc. o/a 20 York Street Holdings Ltd, or Canadian Broadcasting Centre (collectively the “Entities”) and their officers, directors, employees, servants, agents, parents, successors and assigns (collectively the “Representatives”). I release these Entities and Representatives, and each of them, from any and all losses, claims, actions, damages, costs, liabilities, expenses and demands whatsoever (collectively the “Claims”) for death, personal injury, damage or loss to property and any and all other loss or injury, including, without limitation, economic loss or consequential damages (collectively “Damages”) that I may suffer arising from: my participation in the Event, my entering into the Rogers Stadium Limited Partnership o/a Rogers Centre, Metro Toronto Convention Centre, 4033795 Canada Inc. o/a 20 York Street Holdings Ltd, or Canadian Broadcasting Centre and my entering the CN Tower or upon its surrounding lands and premises. This release applies regardless of whether the Damages are occasioned, wholly or in part, by any act or omission of one or more of the Entities or Representatives, whether negligent or grossly negligent or otherwise.

**By signing this Release and Indemnity,** I also agree that the Releasers will make no demand or claim against any other person who could claim against one or more of the Entities and Representatives for the matters this Release and Indemnity covers. I agree that the Releasers will indemnify and save harmless the Entities and the Representatives and each of them from Claims for any and all Damages suffered by me and/or by any other persons arising from: my participation in the Event, my entering into the Rogers Stadium Limited Partnership o/a Rogers Centre, Metro Toronto Convention Centre, 4033795 Canada Inc. o/a 20 York Street Holdings Ltd, or Canadian Broadcasting Centre and my entering the CN Tower or upon its surrounding lands and premises, whether the Damages are occasioned, wholly or in part, by any act or omission of one or more of the Entities or Representatives, whether negligent or grossly negligent or otherwise.

**Photo, video, audio, film, interview release:** I give WWF-Canada permission to take and publish photographs, videotapes, audiotapes, films and interviews of me and/or the child or children named below for current and future use in WWF-Canada materials, including marketing and promotional materials and WWF-Canada’s official website.
